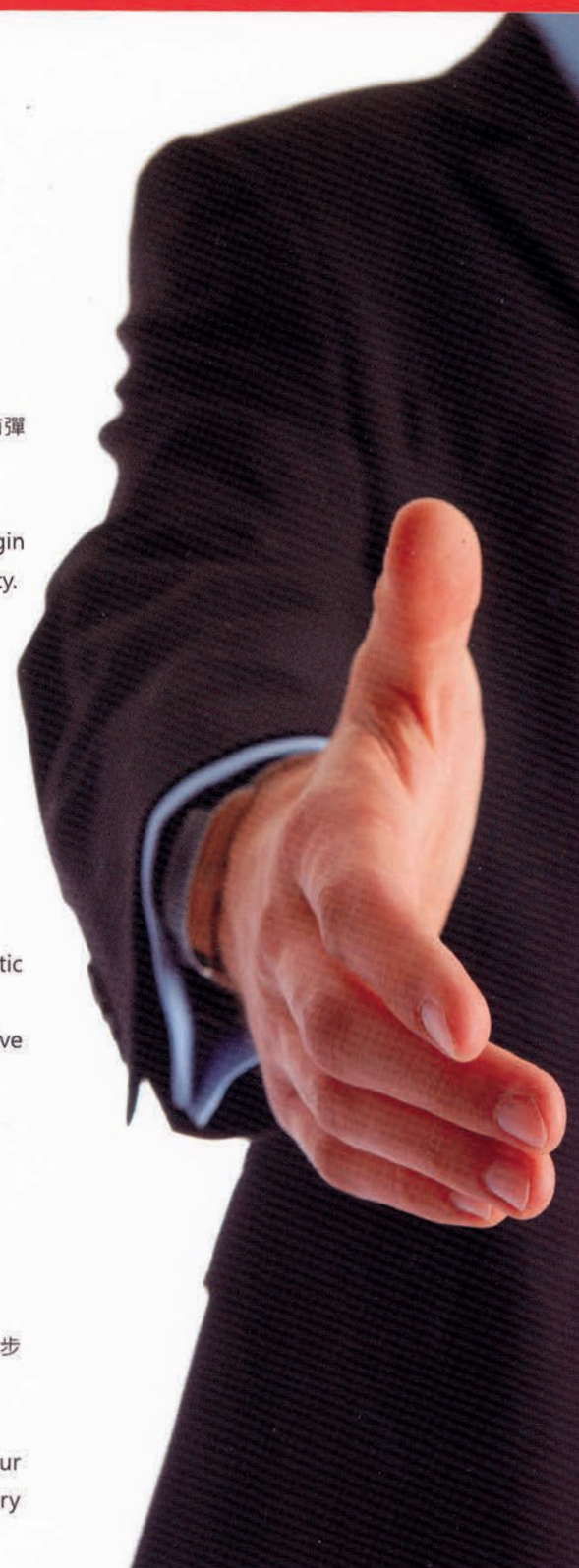

### 例子

假設客人現有港幣100,000 想買入匯豐控股(00005.HK)  
現價72元400股一手

客戶已於72元買入1200股匯豐控股(00005.HK)，總費用為：

= 價格x股數 x (佣金 + 交易徵費 + 交易費 + 結算費 + 印花稅)

= 72 x 1200 x (0.25%+0.003%+0.005%+0.005%+0.1%)

= 86,400 + (216+2.59+4.32+4.32+86.4)

=港幣\$86,713.63

### Example

If the client has HKD\$100,000 and would like to invest in  
HSBC (00005.HK).

Spot price of HSBC (00005.HK) is \$72 per lot (400 shares).  
The client buy 1200 shares of HSBC (00005.HK) at \$72, the  
total charges will be:

= price x number of shares x (commission + transaction  
levy + trading fee+ settlement fee + stamp duty)

= 72 x 1200 x (0.25%+0.003%+0.005%+0.005%+0.1%)

= 86,400 + (216+2.59+4.32+4.32+86.4)

= HKD\$86,713.63
