Heng Fung in travel push

Investment holding company Heng Fung Holdings is branching out into travel and consumer finance services.

The company plans to invest HK\$70 million this year in a wholly owned subsidiary called China Xpress, a travel company with a focus on the mainland. It will also provide travellers cheques and credit card services.

Chairman and managing director Chan Heng-fai said the capital will be used to acquire travel agencies in China and overseas, including four in Australia.

China Xpress is expected to raise a further HK\$400 million to HK\$500 million by introducing strategic partners and forming alliances with mainland banks, Chan said, adding negotiations were already being held with several potential partners.

"China Xpress will be in full operation in

three years and take a further three years to reach maturity," Chan said. "It will contribute profit to Heng Fung in 16 months."

Heng Fung's move to diversify follows it cashing in HK\$180 million last month by agreeing to sell 250 million shares in China Gas, at HK\$0.72 per share.

The sale takes to HK\$345 million the amount of money the company has raised from selling shares in China Gas, Chan said.

Heng Fung also plans to spin off the travel and consumer finance services business for listing in either Hong Kong, Singapore or the United States in two to three years.

The company has cash on hand of HK\$300 million, and Chan said it has no bank borrowings and no intention to seek funding.

Meanwhile, Heng Fung's associated company, Singapore-listed waste-to-energy infrastructure provider EnerSave, plans to build 20 more plants in China in the next five years.

引策略股東集五億 恆鋒擬分拆中國特速

【本報訊】恆鋒集團(185)董事長陳恆輝表示,未來會積極開拓旅遊及消費信貸業務,今年會率先投資七千萬元,收購各地旅行社及金融機構。並會引入策略性股東,集資四至五億元,發展旅遊金融公司一中國特速的業務。

恆鋒的收購目標,包括加拿大、美國及澳洲等地的旅行 社。陳恆輝表示,期望中國特速的業務。可以覆蓋內地 八十多個城市及全球二十個國家。仔並預料今年最少會 收購四間澳洲旅行社。陳恆輝相信,中國特速最快會在 兩、三年間上市集資,而上市地點,僧是香港、新加坡 或美國。由於恆鋒擬發展旅遊及金融合而爲一的業務, 陳恆輝表示,未來亦會入股內地銀行,而股權比例方面,大約是百分之五王十。他們希望以最少資金購買一 些具潛力的公司,進行重紅增值。

另外,恆鋒亦有投資內地環保能源業務,持有新加坡上市公司安利興(EnerSave)約百分之二十五股權。他們的目標是在五年間開設二十家發電廠,每間的投資額爲三千萬美元,相信在投產後,每間電廠可以帶來七百至八百萬元利潤。陳恆輝表示,現時北京、上海、天津和西安等城市,有環保業務正在斟洽中,另外位於惠州的發電廠,相信可以於年尾竣工。



China Xpress intends to open training centres in **10** major countries where cXpress has operations.

China Xpress Management Training Centres will provide training for new managers. Training encompasses travel business management, financial planning, knowledge of travel products and sales and marketing. The objectives of the Training Centres are to cultivate new managers to better manage their departments and ensure profitability.

It will offer a one time comprehensive training, ranging from starting a travel branch or franchise to a wholesale operation. Additionally, refresher courses will be provided yearly and/or on request of all China Xpress associates, officers and members.

China Xpress Branch - Manager Training

The training centres will provide training for Branch Managers of China Xpress Travel companies. Training focuses on Branch Managers who have no experience in the travel business and refresher training for existing Branch Managers.

China Xpress Franchise Store - Store Training

The training centres will provide training for new franchisees. Training will include knowledge / know-how of travel business, management skills, systems and methodologies to ensure that the business is run professionally and profitably.

China Xpress - Specialised Project Training

The training centre will provide customised project training related to the tourism industry, which includes hospitality logistics, travel and tours, transportation and finance.

China Xpress - Travel Planner Training

The training centre will provide training to full and part-time planners handling individual, family and business travel. All planners are required to attend a refresher course conducted on a yearly basis.
